 - 3.5 This registration is subject to constant review in relation to your performance for supply of stores to this Railway. This review is undertaken once a year and should your performance be found unsatisfactory, this Railway reserves the right to delete your name, even before the expiry of the registration period.
 - 3.6 Registration on the approved list does not guarantee award of contract.
 - 3.7 You should promptly advise this office any change, in your address of office, Factory, Partnership deed or any articles of association of your concern since registration, your telephone numbers etc.
 - 3.8 In case any change takes place in the pattern of your manufacturing activity in the constitution of your firm in the capital structure or any other changes relevant to your registration with this office the same should be immediately brought to the notice of this office.
 - 3.9 This Railway administration reserves the right to de-registration/remove your firm from the approved list for unsatisfactory performance or for failure to abide by IRS Conditions of Contract or any conditions as laid down in the foregoing pares.
